## RULES & GUIDELINES

### 1. MEMBERSHIP RIGHTS

- THE BLK ASS FLEA MKT (BAFM) TEAM RESERVES THE RIGHT TO TERMINATE ANY MEMBERSHIP AT ITS DISCRETION. GROUNDS FOR TERMINATION INCLUDE, BUT ARE NOT LIMITED TO, FAILURE TO COMPLY WITH MEMBERSHIP GUIDELINES AND ANY CONDUCT DEEMED INAPPROPRIATE BY THE BAFM TEAM.

### 2. MEMBERSHIP DUES

- PAYMENT REQUIREMENTS: MEMBERSHIP DUES MUST BE PAID IN FULL BY THE SPECIFIED PAYMENT DUE DATE. UNPAID DUES WILL RESULT IN THE FORFEITURE OF MEMBERSHIP STATUS AND ASSOCIATED BENEFITS.
- NON-REFUNDABLE POLICY: ALL MEMBERSHIP DUES ARE NON-REFUNDABLE, REGARDLESS OF USAGE OR TERMINATION CIRCUMSTANCES.

### 3. MEMBERSHIP TRANSFERABILITY

- THE "LOCKED-IN" MEMBERSHIP MAY BE TRANSFERRED TO ANOTHER VENDOR UPON PRIOR NOTICE AND WRITTEN APPROVAL FROM THE BAFM TEAM. TRANSFER REQUESTS ARE SUBJECT TO REVIEW AND ACCEPTANCE.

### 4. EVENT COMMITMENT REQUIREMENTS

- LOCKED-IN MEMBERS: MUST COMMIT TO ALL SIX BAFM EVENTS AND AT LEAST TWO OUT OF THREE PARTNERSHIP EVENTS WITHIN THE PROGRAM YEAR.
- FIRST-DIBS MEMBERS: MUST COMMIT TO ALL PRE-SELECTED MARKETS AS DESIGNATED DURING THE APPLICATION PROCESS. FAILURE TO ATTEND AGREED-UPON EVENTS MAY IMPACT ELIGIBILITY FOR FUTURE SEASONS.
- COMMITMENT COMPLIANCE: MEMBERS ARE REQUIRED TO ADHERE TO THEIR CHOSEN MEMBERSHIP GROUP'S EVENT SCHEDULE. FAILURE TO MEET THE COMMITMENT CRITERIA MAY RESULT IN MEMBERSHIP TERMINATION AND INELIGIBILITY FOR THE 2026 SEASON.

### 5. EVENT PARTICIPATION AND TRADING POLICY

- LOCKED-IN MEMBERS: LOCKED-IN MEMBERS MUST ATTEND ALL BAFM EVENTS AS OUTLINED IN THEIR MEMBERSHIP.
- FIRST-DIBS MEMBERS: MAY TRADE THEIR SELECTED MARKET SPOTS WITH NON-MEMBER VENDORS, SUBJECT TO CLEARANCE FROM BAFM STAFF TO ENSURE SEAMLESS EVENT COORDINATION.

### 6. SCOPE OF MEMBERSHIP DUES

- MEMBERSHIP DUES INCLUDE PARTICIPATION IN BAFM MARKET EVENTS AND DESIGNATED PARTNERSHIP EVENTS. PRIVATE EVENT VENDING OPPORTUNITIES MAY BE OFFERED TO MEMBERS AT A DISCOUNTED VENDOR FEE ON A CASE-BY-CASE BASIS.

### 7. PRODUCT ELIGIBILITY

- THE FOLLOWING PRODUCT CATEGORIES ARE INELIGIBLE FOR BAFM MEMBERSHIP: HOT FOOD, HEALTH/SUPPLEMENTS/CBD/THC PRODUCTS, DROP-SHIPPED ITEMS, AND IN-PERSON SERVICES. BAFM RESERVES THE RIGHT TO ASSESS PRODUCT ELIGIBILITY UPON APPLICATION.

### 8. FOOD DISCOUNT POLICY

- FOOD DISCOUNTS ARE CONTINGENT UPON VENDOR PARTICIPATION AND MAY VARY BY EVENT BASED ON VENDOR TURNOUT.
